Charity Place fundraising Terms and Conditions

By accepting a charity place from Teenage Cancer Trust I agree that:

1. I will inform the Teenage Cancer Trust Mass Participation Team immediately if I am unable to take part in the event.

I understand that, if I wish to defer my charity place, Teenage Cancer Trust may be able to do so if I meet the following criteria:

- I've raised at least 50% 6 weeks prior to the challenge date.
- I haven't deferred entry before.
- I've notified Teenage Cancer Trust by the Friday before event day – this is the absolute deadline.
- I may only defer for one year.

Deferrals are always at the discretion of Teenage Cancer Trust. The ability to defer to the next year will be dependent on there being enough places in the following year. Teenage Cancer Trust reserves the right to refuse a deferral.
